PUBLIC NOTICE LOCAL STATE BOARD PUBLIC HEARING

The Kentucky Board of Education has scheduled a local State Board public hearing on the proposed District Facility Plan for Friday, January 18, 2002 at the Rockcastle County Board of Education office a 6:30 p.m.. The District Facility Plan lists the pending capital construction and/or renovation projects that the school district may undertake, and the priority order, if applicable, that projects will be initiated.

The local Board of Education, after due process, will forward the approved District Facility Plan to the Kentucky Department of Education for ultimate approval by the State Board of Education.

The local State Board public hearing is being scheduled in accordance with KRS 157.620, and regulated by 702-KAR-1:001.
